

Euler Hermes named best trade credit insurer by *Global Finance* for the second consecutive year

PARIS – 14 NOVEMBER 2013 – [Euler Hermes](#) was named best global [trade credit insurer](#) in the 2013 *Global Finance* awards for “Best Global Insurers”, repeating its achievement in the 2012 *Global Finance* “Best Global Risk Management Providers.” *Global Finance* is a monthly magazine for corporate leaders, bankers and investors with a readership in 163 countries.

In its awards announcement *Global Finance* stated “As they operate in an increasingly complex and competitive environment, businesses in all parts of the world must find a way to address larger and more challenging exposure.”

In addition to Euler Hermes’ selection as best global trade credit insurer, [Allianz](#) received a total of 13 awards, notably as best global casualty insurer and best global crime/fidelity insurer plus 11 awards across five different regions.
